A report regarding Council Social Media Policy was presented by the City Clerk.

"THAT the City Council Social Media Policy as attached to the City Clerk's report dated February 2, 2017 be adopted."

- By adding "Instagram or any other form of Social Media"; to the list of social media means in the first paragraph under **PURPOSE**.
- By deleting the words "Council and the CAO" and replacing with the words "Council or the CAO" under part 4. Controversy.
- By deleting the paragraph in part 5. Separation and replacing with "Make sure your social media profile does not interfere with your job or commitments to people. It is safest to keep your social media posts separate from posts related to the City of Swift Current. Be clear that your posts and comments are solely your own and not that of you as a representative of the City of Swift Current. Sharing posts from City social media sites or from fellow Councillors to provide information to as many people as possible is encouraged while following the above guidelines on separation."

"THAT the Council Social Media Policy be adopted as amended as follows:

PURPOSE:

For the purposes of this policy, social media means any facility for online publication and commentary, including without limitation blogs, wiki pages, and social networking sites such as Facebook, LinkedIn, Twitter, Flickr, Right Now Media, Snapchat,

YouTube and Instagram or any other form of social media. This policy is in addition to and compliments any existing or future policies regarding the use of technology, computers, e-mail and the internet.

All uses of social media must follow the same ethical standards that the City of Swift Current employees must otherwise follow as per the City's Social Media Policy.

SCOPE:

To provide guidelines in acceptable Social Media usage for elected officials of the City of Swift Current.

POLICY:

Council representatives using social media must:

- Only disclose publicly available information. No comment will be made on Social Media sites regarding confidential, private or legal matters.
- Ensure that no copyrighted or trademarked material is published without permission.
- Ensure that information posted online is not illegal, libellous, discriminatory, defamatory, abusive, or obscene.

1. Confidentiality

Confidential information includes things such as unpublished details about the City's clients, customers, employees, details of upcoming events or projects that have not been authorized for dissemination, financial information that is outside the normal reported information, departmental issues, and names of people attending any groups or activities partnering with the City of Swift Current without their permission.

2. Privacy

Any information related to the City of Swift Current should only be what can be found on City of Swift Current website and should not disclose personal details.

3. Respect

Topics that may be considered objectionable or inflammatory should be avoided. If stating your opinion, be clear that it is your personal ideas and not a representation of the Council as a whole or the City.

4. Controversy

The public will use social media as a platform to address and initiate debate. The City's Communication Department is equipped to respond as directed by Council or the CAO.

5. Separation

Make sure your social media profile does not interfere with your job or commitments to people. It is safest to keep your social media posts separate from posts related to the City of Swift Current. Be clear that your posts and comments are solely your own and not that of you as a representative of the City of Swift Current. Sharing posts from City social media sites or from fellow Councillors to provide information to as many people as possible is encouraged while following the above guidelines on separation.

ENFORCEMENT:

Violations of the policy will be subject to review by Council as a whole to determine appropriate consequence."
