## PROCLAMATIONS

Kimi Duzan and Candace Toma of SaskAbilities attended to proclaim August 15th to 21st as “SaskAbilities Awareness Week” in Swift Current.

## ITEMS FOR ACTION

### CORPORATE SERVICES

City Council approved spending in the amount of \$2,019,188.43 for the period of June 17th to 28th, 2021.

City Council approved spending in the amount of \$5,230,409.89 for the period of June 29th to July 9th, 2021.

### INFRASTRUCTURE & OPERATIONS

City Council approved the installation of approximately 635 meters of 200mm force main at Lift Station #7 and awarded the contract to KMS Construction Ltd based on unit pricing to a total upset fee of \$319,000.00. This project will result in the mitigation of future capacity issues as the City grows.

City Council approved the supply of a 2021 RPM 217 Snow Blower from Industrial Machine Ltd for the sum of \$142,146.00 to be utilized by Transportation Services, Streets & Roadways.

Following notice that the City was successful in its application for funding through the SGI – Provincial Traffic Safety Fund to enhance safety at crosswalks located at Riverside and Riverdene Parks, Council approved the installation of Rectangular Rapid Flashing Beacons and curb extensions at these locations. Materials are funded fully through the grant.

### COMMUNITY SERVICES

City Council approved the installation of two additional flagpoles at the City Flag Court for the sum of \$12,000.00. The flagpoles will proudly fly the Treaty 4 and Métis Nation flags.

City Council awarded the five-year operating lease of 46 golf carts for Chinook Golf Course to Oakcreek Golf & Turf at an annual rate of \$43,884.00 plus GST, commencing May 1st, 2022.

### CHIEF ADMINISTRATIVE OFFICER

City Council rescinded an agreement with J&P Bardahl Investments Ltd, approving a new debt settlement that will see the City paid \$400,000.00 cash settlement on outstanding debt owed to the City, with associated lands to be rezoned for subdivision.
