Subject: 2021 List of Lands with Arrears

BACKGROUND

Attached is the List of Lands with Arrears as of October 4th, 2021 to be presented to Council in compliance with Section 3 of *The Tax Enforcement Act*.

The Tax Enforcement Act, Section 3, states that a Municipality may direct that all properties that do not exceed one half of the preceding years tax levy be removed. In 2001, Council carried a motion in support of this option and the list does not include those properties.

DISCUSSION

The Tax Enforcement List will be published in the October 28th, 2021 edition of the Southwest Booster. Courtesy phone calls have been made to property owners on the Tax Enforcement List, requesting payment to clear arrears and advising that the City intends to publish the list and register a lien on their property. After the posting of arrears in the paper, property owners will have 60 days to pay the arrears, after which time a tax lien shall be registered against their title at the Information Services Corporation Office. Prior to the list being published, the Taxation Department will continue to collect unpaid amounts and remove names from the list as required.

All fees paid by the City of Swift Current for advertising and registration of liens will be added to tax cards as required and in their proportioned amounts.

Subject: **Water Treatment Plant Residual Management Pipeline**

BACKGROUND

Under the Department of Fisheries and Oceans and Saskatchewan Water Security Agency's regulations, the Water Treatment Plant is required to collect and dispose clarifier sludge and chlorinated filter backwash water, in accordance with updated environmental standards. Currently, this waste is discharged into the Swift Current Creek. The Water Security Agency requires completion of the residual management system by March 31st, 2022.

Trans Canada Contracting Ltd. of Regina, SK was awarded the contract to construct the residuals pumping station in June of this year. The pipeline installation portion of this project will tie the pumping station to the sanitary system in the McIntyre Industrial Park.

During the preliminary phase of engineering, it was identified that Lift Station # 12 would require upgrades to keep up with sanitary flows from McIntyre Industrial, Water Treatment Plant residuals, and development of South Munro Industrial. These upgrades will include improvements to the electrical and pump systems and must be completed before seasonal peak water usage in 2022.

DISCUSSION

Final design of the pipeline was completed by MPE Engineering of Regina, SK. The project was posted on SaskTenders and the City website for two (2) weeks closing October 14th, 2021. Five (5) bids were received, ranging from \$492,922.95 to \$1,029,896.00 (PST included, GST excluded).

Mastec Canada, a local company with offices in the City of Swift Current, was selected as the lowest cost bid.

The Water Treatment Plant Residual Management project is budgeted in the Capital Budget for \$2,548,978.00. With \$1,665,838.76 committed for the construction of the residual pumping station, \$206,734.42 budgeted for engineering, and \$37,360.97 in costs

related to downstream affect studies, heritage investigation, and internal labour, a total of \$639,043.85 remains for pipeline construction.

RECOMMENDATION

THAT Council awards the contract for the Residual Management Pipeline to Mastec Canada of Swift Current, SK, for a fee of \$492,922.95 (PST included, GST excluded) and that the Mayor and the City Clerk be authorized to sign the contract.

Subject: **City of Swift Current Safe Restart Grant Program Allocation**

BACKGROUND

On August 23rd, 2021 the City of Swift Current announced its plans for the distribution of the Safe Restart Program Funding from the Federal Government to Saskatchewan Municipalities. As part of this plan \$93,900 was set aside to provide support to City of Swift Current non-profit and volunteer-based organizations who aim to provide programs and services that support Economic, Social and Cultural Development, Justice and Health Initiatives, Senior and Youth programming or Community Recreation based Infrastructure Development and Maintenance in our communities.

On August 24th, 2021 the applications for grant funding were made available to the public. After three (3) weeks of continuous and varied advertising., the Safe Restart Program grant applications were submitted to Community Services by the September 15th, 2021 deadline.

DISCUSSION

The Safe Restart Program Funding Grant was developed by the City of Swift Current administration to help assist, maintain, improve and expand opportunities for Swift Current residents. To derive the benefits from initiatives that sustain a healthy and active community and help alleviate effects of COVID-19. A priority for the funding was designed to be given to new initiatives that are designed with COVID-19 measures in mind and are in place or developed to assist participation return (as a result of) COVID-19.

In order to allocate the grant, the following key criteria were considered:

- Projects or programs must have been or be offered between May 17th, 2021 and March 15th, 2022.
- Follow up report with eligible receipts must be able to be provided by March 15th, 2022. Funds will not be distributed until the follow up report is received.
- The applicant must be a City of Swift Current, non-profit organization providing a benefit to one of the seven (7) project categories:

1. Economic Development
2. Social Development
3. Justice Initiatives
4. Senior and Youth Programs
5. Cultural Development
6. Community Sport, Culture or Recreation based Infrastructure Development and Maintenance Initiatives
7. Health Initiatives

- New initiatives designed to meet COVID-19 short falls will be given priority.
- Programs/projects that already received grant funding from the City of Swift Current Saskatchewan Lotteries would not receive priority of funding dollars.
- Projects, programs or events for consideration should not duplicate existing services.
- City of Swift Current must be publicly acknowledged by any organization receiving a grant during their promotion or acknowledgement of their activities.

Twenty-one (21) applications have been submitted from a variety of Swift Current organizations, with a requested total of \$153,574. Based on the key criteria established all twenty-one (21) applications are being recommended to share in the \$93,900 from the Safe Restart Grant.

The applications and funding amounts were reviewed by the Recreation, Parks and Culture Board on October 7th, 2021 with no concerns.

RECOMMENDATION

THAT City Council approves the attached list of applications and funding amount under the Safe Restart Grant Program.

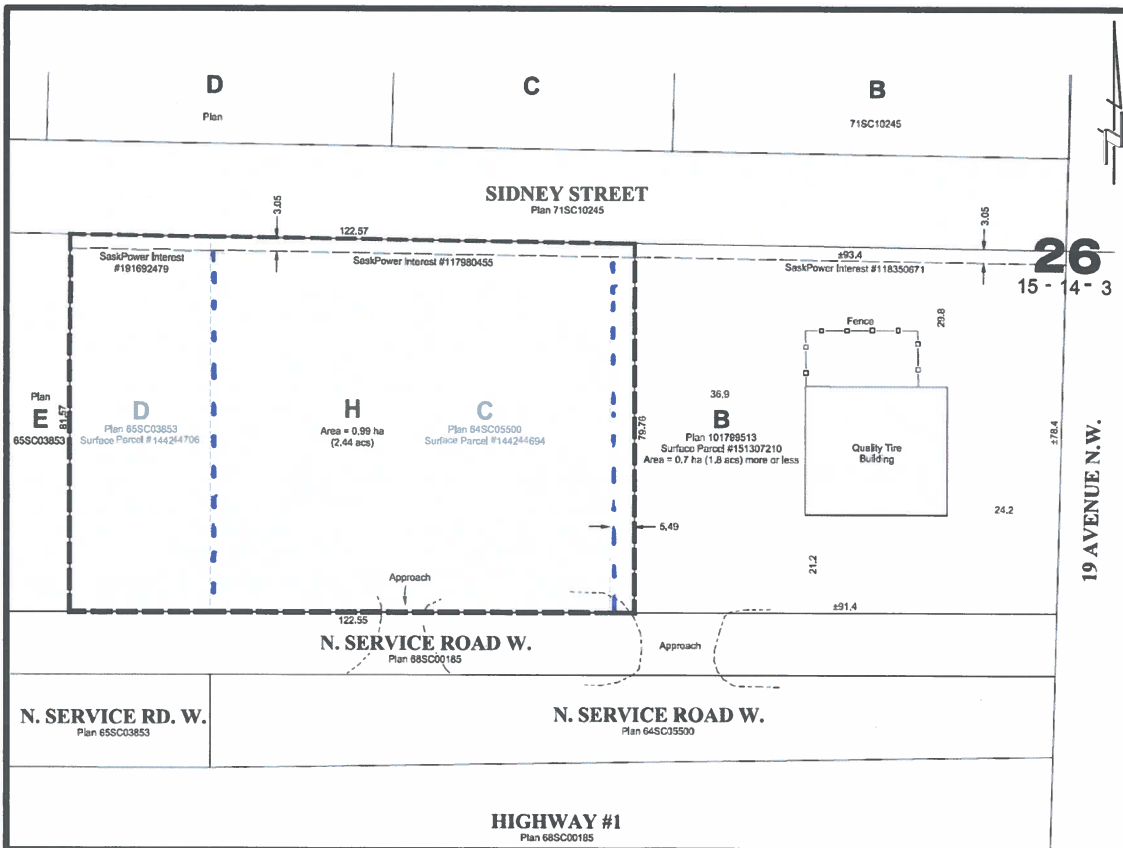

BACKGROUND

The City has received an application from the two property owners (Quattro Land Co. Inc. and 102129026 Saskatchewan Ltd.) to subdivide and consolidate three lots located in an C3-Highway Commercial District. This proposal is required for the applicants' future development plans.



DISCUSSION

This proposal was reviewed against the City’s Development Plan, Zoning Bylaw and Subdivision Bylaw, as well as other bylaws, policies and statutory requirements, and no issues were identified in this review.


The attached Plan of Proposed Subdivision and Consolidation of these three lots will subdivide approximately 4,700 square feet from Parcel B. 

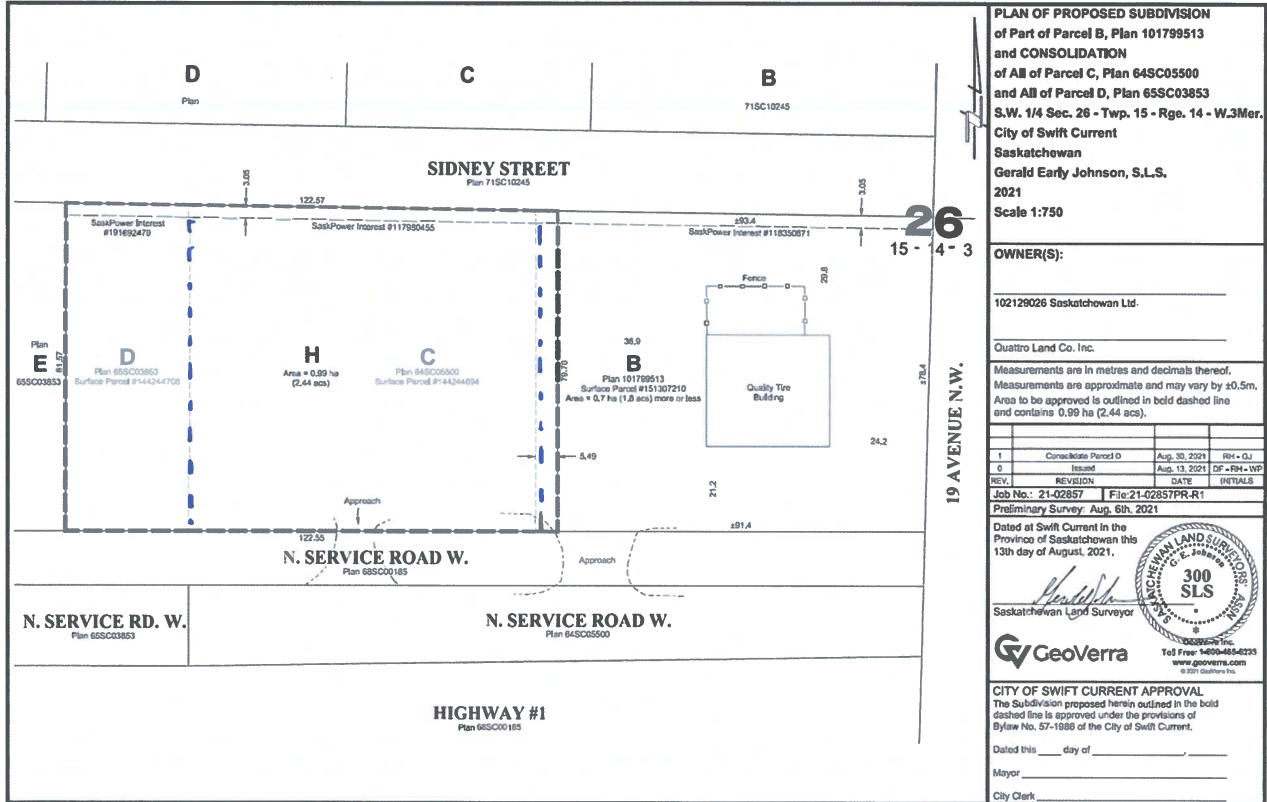
