BACKGROUND

In September 2021 Murray Walter, QC, City Solicitor, advised of his retirement after 41 years of providing legal services to the City of Swift Current.

DISCUSSION

Duties of a City Solicitor is to provide legal, strategic, and business advice to City Council and Senior Administration with the knowledge and understanding of the City's strategic goals and objectives. In addition, they must have the ability to draft a wide variety of legal documents, knowledge of provincial and federal statutes and regulations, municipal bylaws, and general legal principles with the skill to interpret and apply legislation to ensure statutory compliance and liability protection, including legal research and offer risk assessment and to represent the City in courts of all levels and administrative tribunals.

Administration began the quest for potential candidates within local law firms. Upon a thorough review of proposals received, MacBean Tessem's submission provided a similar rate, arrangement, and qualifying accommodation as the previous City Solicitor, which worked extremely well for many years.

The MacBean Tessem Law firm traces its roots back to 1905 when the founding firm of Smythe, Begg & Hayes opened its doors in Swift Current.

With that, I am pleased to recommend Logan Spearing of the MacBean Tessem Law Firm. Logan was raised in Swift Current and attended the University of Saskatchewan to obtain his Bachelor of Arts in political studies and international development, then entered the College of Law where he obtained his Juris Doctor (J.D.) in 2013.

Logan first came to MacBean Tessem as a summer student in 2011 and 2012. In 2013 he returned as an articling student, completing his articles and became an associate in 2014, and in 2015 Logan became a partner.

Logan is currently a member of the Canadian Bar Association, the Southwest Bar Association, and the Saskatchewan Trial Lawyers Association.

(J & P Bardahl Investments Ltd./Creekside Developments)

BACKGROUND

In 2016, Council had approved a subdivision request from J & P Bardahl Investments Ltd creating Parcels 1 to 3, Plan 102231649 within the NE quarter of Section 31-15-13-W3M. Altogether these parcels are approximately 1.5 hectares/3.8 acres in size.

The City has received a subsequent application to further subdivide the subject properties. The proposal will create nine (9) lots for single-detached residential dwellings, which are a permitted use in the R3 Residential District. The application has met or is in the process of meeting the terms listed in the both the original subdivision requirements as well as the terms that are required for this proposed subdivision.

DISCUSSION

The Plan of Proposed Subdivision will subdivide Parcels 1 to 3, Plan 102231649 to create nine (9) lots shown as Lots 1 to 9, Block E and ranging from 0.32ac to 0.61ac in size. These lots will accommodate the development of single-detached residential dwellings.

To meet the provincial and municipal requirements for development of an area identified within a flood hazard area, the Developer has effectively removed the subject properties from the flood plain. The lots have been raised to an elevation that meets or exceeds the 1:500 year estimated peak water level for this location, as shown by the rough grade plan provided by GeoVerra and the updated flood hazard map from WSP consultants and Golder Associates. The Developer will also provide the geotechnical report from a qualified professional at a later date.

The lot development plans submitted as part of the application also designate the minimum grading and building elevations required to maintain the area outside the limits of the flood hazard area. These plans also establish the servicing requirements and driveway locations for each lot. All future development and building permits will be required to adhere to these development plans.

This proposal was also circulated to various agencies for their review. Comments received are as follows:

Department of Highways SaskPower	No objection.	
Water Security Agency	Building sites at or above the recommended minimum building elevation of 734.25m; remainder of lot could be slightly impacted if left below 734.0m but would most likely be of minimum consequence due to nominal water depth and if landscaped with a surface to withstand temporary overland flooding.	
SaskTel	Existing facilities and easements to be maintained,	
City of Swift Current	relocated or terminated at Developer's cost; new	
Shaw Cable	facilities and easements may be required under a	
SaskEnergy	servicing agreement with the Developer.


