CORPORATE SERVICES

City Council approved General Revenue Fund disbursements in the amount of \$2,145,037.38 for the period of March 11th to 28th, 2022 and \$1,431,596.01 for the period of March 29th to April 7th, 2022.

City Council gave Notice of Motion of its intention to consider Bylaws to establish: the Mill Rate, Mill Rate Factors, a Special Levy to fund the Long Term Care facility, and the exemption of the 2022 Assessment of certain properties.

INFRASTRUCTURE AND OPERATIONS

City Council awarded its 2022 Concrete & Paving Contract to Mobile Paving, Ltd. of Swift Current, SK, to a total upset fee of \$1,372,195.52.

City Council awarded its 2022 Asphalt Maintenance Contract to Mobile Paving, Ltd. of Swift Current, SK, to a total upset fee of \$400,000.

City Council approved a budget increase of \$53,500 to the 2022 Herbert Street Storm Capital Budget, with \$30,000 re-allocated from the 2022 Paved Street Rehabilitation Capital Budget and \$23,500 from the 2022 Storm Sewer Main Rehabilitation Capital Budget.

City Council awarded its 2022 Herbert Street Storm Contract to Knudsen Excavating Ltd. of Swift Current, SK, to a total upset fee of \$223,438.04.

City Council awarded the purchase of a 2022 Rough Cut Mower to Martin Deerline of Calgary, AB.

City Council provided notice of intent to consider discretionary use in a DC2-C1 - Direct Control Central Downtown District for the proposed development of a Cannabis Retail Store at 42D Central Ave N.
