## **PROCLAMATIONS**

## **ITEMS FOR ACTION**

#### **CORPORATE SERVICES**

City Council approved General Revenue Fund disbursements in the amount of \$2,339,725.04 for the period of June 2 to 13, 2022.

City Council approved amending the Municipal Economic Funding Enhancement Program 2020 Funding Agreement, by reducing the funding allocated to the Friesen Street Storm Rehabilitation project to include the Inclusive/Accessible Park and Playground project.

A notice of motion was given, advising the public of City Council's intention to consider a borrowing bylaw for financing within Utility Operations for 2022 Capital Investments.

## **INFRASTRUCTURE & OPERATIONS**

City Council approved the required funding from the 2023 Capital Budget in the sum of \$1,983,000 in order to award the contracts for the North Hill Reservoir Pump Station Upgrade. To secure financing, prior to rising interest rates, a notice of motion was given advising the public of Council's intention to consider a borrowing bylaw for financing within Utility Operations for the North Hill Reservoir Pump Station Upgrade.

City Council awarded the North Hill Reservoir Pump Station Upgrade Contract to Leeville Construction of Moose Jaw, SK based on unit pricing to a total upset fee of \$3,371,028.43 and Construction Management Services to Associated Engineering of Saskatoon, SK based on unit pricing to a total upset fee of \$211,874.92.

### **CITY CLERK**

City Council supported the re-appointment of Ashley Stradeski to the Municipal Employees' Pension Commission as a Joint Representative of Employers of Police Officers and Fire Fighters that participate in the Commission for a four (4) year term commencing September 1, 2022.

## **CHIEF ADMINISTRATIVE OFFICER**

City Council directed Administration to begin the process to depart from the Chinook Regional Library System, so that the Swift Current Public Library becomes a Municipal Library under the direction of the City of Swift Current; and approved the proposal of a boundary change to be same as the existing boundaries encompassing the City; with a public notice of Council's intention for a public hearing to be held at a future date.
