CITY OF SWIFT CURRENT **PUBLIC NOTICE** PROPOSED LIBRARY BOUNDARY CHANGE

The City of Swift Current hereby gives Public Notice pursuant to Section 4.1 of The Public Libraries Act, 1996 of its intention to change the library boundary.

On June 27, 2022 Council approved a motion to establish a municipal library in Swift Current, The current Public Library operates under the Chinook Regional Library system. Currently Swift Current residents pay for all of the operating and facility costs. The objective of this change is to enable the City of Swift Current to directly manage and control the budget, set priorities, and establish levels of service delivery for the Public Library. In that regard, the City will be applying for a boundary change for the Public Library by proposing the boundaries of the new municipal library be those of the existing City limits as outlined in the map below.

Subject: 2022 List of Lands with Arrears

BACKGROUND

Attached is the List of Lands with Arrears as of November 3rd, 2022 to be presented to Council in compliance with Section 3 of *The Tax Enforcement Act*.

The Tax Enforcement Act, Section 3, states that a Municipality may direct that all properties that do not exceed one half of the preceding years tax levy be removed. In 2001, Council carried a motion in support of this option and the list does not include those properties.

DISCUSSION

The Tax Enforcement List will be published in the November 24th, 2022 edition of the Southwest Booster. Courtesy phone calls have been made to property owners on the Tax Enforcement List, requesting payment to clear arrears and advising that the City intends to publish the list and register a lien on their property. After the posting of arrears in the paper, property owners will have 60 days to pay the arrears, after which time a tax lien shall be registered against their title at the Information Services Corporation Office. Prior to the list being published, the Taxation Department will continue to collect unpaid amounts and remove names from the list as required.

All fees paid by the City of Swift Current for advertising and registration of liens will be added to tax cards as required and in their proportioned amounts.

Accounts Receivable and Unclaimed Deposits

BACKGROUND

In the course of doing business, the City creates accounts receivable for the services provided to customers. Occasionally the City has difficulty collecting all of the outstanding accounts receivable. When this occurs, all cost-effective measures of collecting the delinquent accounts are pursued, including the use of internal staff and a collection agency. Once, all avenues for collection have been exhausted and the receivable remains outstanding, it is necessary to deem the account as uncollectable and write-off the balance owing.

In 2020, the Covid-19 pandemic caused rising global economic pressures. During this time the City established measures to work with customers to collect payment on accounts, including temporary postponements of cutoff and late payment charges. From a collections standpoint, we continue to observe the effects of the economic pressures resulting from the pandemic, which are likely to continue in the years to come.

The accounts being requested for write-off have been outstanding since December 31st, 2019 and December 31st, 2020, and continue to be outstanding. Typically, the request to write-off delinquent accounts is brought forward to Council for approval on an annual basis; however, the report for accounts outstanding as of December 31st, 2019 was deferred in 2021 as we continued to work toward receiving payment on these accounts.

It should be noted that writing off uncollectable amounts does not prevent the City from continuing to pursue collection activity on that account if new contact information becomes available. Also, if that customer applies for a City of Swift Current service in the future, any unpaid balance from the previous account(s) must be paid in full prior to issuing a new account.

In addition, over the course of 2019 and 2020, some utility deposit refunds were returned due to incorrect forwarding addresses. To date, the City has been unable to locate the

customer and the customer has not contacted the City for reimbursement. These unclaimed refunds will be written off against the delinquent accounts receivable.

In 2019, a total of \$33,848,741.93 was billed through the utility billing and general accounts receivable areas. The amounts proposed for write-off equate to 0.173% of the total 2019 billings.

In 2020, a total of \$33,621,655.54 was billed through the utility billing and general accounts receivable areas. The amounts proposed for write-off equate to 0.189% of the total 2020 billings.

For comparative purposes, the Accounts Receivable written off in previous years is as follows:

- 2020 \$63,273 of \$35,390,861 billed (0.178%)
- 2019 \$28,037 of \$34,129,775 billed (0.082%)
- 2018 \$56,289 of \$29,377,901 billed (0.178%)


