A Public Hearing was held in connection with Council's intention to pursue the process of departing from the Chinook Regional Library System, such that the Swift Current Public Library becomes a Municipal Library under the direction of the City of Swift Current, and to continue operations of the "new Municipal Library" within the existing boundaries encompassing Swift Current City Limits.
