Re: Community Awareness for Funding Requests of a Wheelchair Accessible Vehicle

Silver Wings Access Van Inc. (SWAVI) and The Meadows Auxiliary is pleased to present this information to you. The Meadows Auxiliary, a Canada Revenue Agency charity, is proud to partner with SWAVI to issue income tax receipts for donations designated for the van.

The Meadows is our 225-bed long term care facility in Swift Current. Many residents require wheelchairs for mobility and activities of daily life. The goal of SWAVI is to purchase an accessible van for use by all residents. Meadow's residents may be your parents or grandparents, friends from high school, the owner of your favourite restaurant, builders and supporters of our communities, your neighbour on the farm. It may be the one you love the most.

Currently, not every resident has access to our community activities because of the style or size of their wheelchair. As well, barriers exist within the accessible transportation offered within the city. For instance, the Abilities Access bus is not accessible to all wheelchairs because certain styles do not fit through the vehicle's door. Residents who are able to use the service are limited to daytime events, as the Access Transit service runs only from 8:00 am - 6:00 pm weekdays, with very limited service on weekends. This means that access to transport folks in wheelchairs in the evening and out of city limits is simply unavailable, putting family activities and social events out of reach for most of our residents.

With your help, we can give these residents the same freedom and mobility that most of us enjoy. By purchasing a customized accessible van, all of our residents would have the opportunity to attend recreational therapy activities offered outside of our building, or any community event, day or night. Our plan is to provide use of the van for no charge, other than refueling, to resident's family members, friends, or volunteers upon providing a clean drivers abstract and completing van safety training session. This would mean that friends and family members could bring their loved ones to family weddings, a visit to their farm, to a sporting event such as Bronco game or 57's game, a visit to the museum, art gallery or library, or just a drive in the country.

Silver Wings Access Van Inc. is a registered non-profit corporation, created with the intention of inclusion and accessibility for residents, to eliminate current transportation barriers.

I respectfully seek your support, so that we can reach our goal of \$140,148.03 to provide our residents, your neighbours, friends, family, and loved ones the mobility and freedom they so deserve.

Kay Tsougrianis Dental Appointments Story

This is the story of my mother, Kay Tsougrianis who is a resident of the Meadows Long term Care in Swift Current, SK. Kay had been having dental problems and needed to see a dentist on three occasions in 2022.

Getting Kay to her dental appointments was a problem because she was no longer able to take care of herself, could not walk, and required a Broda chair (reclined chair) to sit in. The only option to transport Kay to her dentist's office was by a wheelchair that could fit in the van used for transporting residents of the Meadows (City of Swift Current/Sask Abilities Access Transit Bus). However, Kay was not comfortable or safe travelling in a standard wheelchair.



Kay's sons, George and Nick chose not to use a wheelchair to get Kay to her dental appointments. Instead, they decided to transport Kay from the Meadows to her dentist's office on foot by pushing Kay in her Broda chair to her appointments.

On one occasion, in April 2022, Kay and her son Nick left the Meadows on foot to go to her dental appointment. Nick was pushing his mother in her Broda chair. It was a very cold and windy day, with blowing dust from the gravel on the streets. Kay was cold, very uncomfortable, and wanted to turn around and go back to the Meadows.

Nick got his mother to her appointment by pushing her four blocks down the sidewalks and across the streets to her dentist's office on Saskatchewan Drive. After her dental appointment, Nick pushed his mother back to the Meadows, and she was crying because of the cold and extreme windy conditions.

After his experience, Nick contacted the Meadows and asked if there were any plans for proper transportation options for Meadows's residents. They said there were plans to acquire and operate a vehicle that could transport patients in a Broda chair.

Kay's story is why Nick got involved in helping get a vehicle for the Meadows that can accommodate the transport of residents that cannot travel in a standard wheelchair.

Our family feels it is important and imperative to have **proper transportation services with no barriers** for all Swift Current residents.

Regarding: the Silver Wings Access Van Incorporated

Please accept this letter as an expression of concern, from the family of Jake and Margaret Dyck, to address the need for an ability access transport van for the residence of the Meadows Long Term Care (MLTC). The following will identify a couple of experiences our family has faced with trying to include our parents in family functions in our community. Margaret has lived in the MLTC since January 2020 and Jake since December 2021.

On March 13, 2023 (4 months in advance), we called the Swift Current Ability Bus to arrange for my parent's to be able to attend their youngest grandchild's wedding held within the City of Swift Current on July 15, 2023. Although the wedding is at 2:00 PM, we were only able to arrange a pick up time at 12:45 PM and a return transport at 4:45 PM from and to the MLTC on that day. There is no availability to be taken to a second location within those hours, therefore the best hope is the weather allows us to spend time outside or that the church will be open the entire afternoon.



In June 2022, we again tried to arrange transportation for our parents to attend a family reunion south of Beverley, SK, a distance of less than 20 kms. We learned that the Swift Current Ability Bus does not have insurance to travel outside Swift Current City limits. We contacted a few known churches, the disability home facility and private long term care facilities and our requests were denied and received the suggestion that we contact the Swift Current Ability Bus (already known as not an option for us). My parents were not able to arrange transport to the reunion held on a farm outside of Beverley.

In September 2021, we arranged for the Swift Current Ability Bus to transport Margaret for a vision care appointment. Once again there was a several hour time period between pick up and drop off. Following her appointment, we pushed her in her wheel chair up hill and over rough streets, and she was bounced off sidewalks causing much discomfort for her to get to where we waited for the scheduled pick up time for her to be returned to the MLTC.

Our family recognizes we are not the only ones struggling to transport our loved ones as there are many. We appreciate the hard work of the Meadows Auxiliary and the interest in getting a van for the residents of the MLTC.

Elaine's Story - Art Gallery

I got to know Elaine while she was a resident at the Meadows. Elaine was often working on art projects, including painting, diamond art images, and more. Her creative mind attracted many and her caring nature drew many more in the way she 'looked out' for her housemates.

During one of our visits, Elaine commented how she would love to visit the Swift Current Art Gallery; a favourite local artist, Bill Philpott had a showing. "Oh great, I'll check with the bus and see when you can go!", I said.

Upon contact with our community access bus, I found that they could not accommodate Elaine's request. Her wheelchair was 1 1/2" too wide to fit through the bus door. Heart to the floor right there.

Because of 1 1/2" my friend could not access our community. There are no options for folks with wider and different styles of wheelchairs to do anything outside of the Meadows.

Long term care is not a prison, it is another fork in the road of life. You may have to say goodbye to the home you knew, accept physical and mental changes, but you should not have to give up your freedom and choice!

Without access to our community and events, being in a wheelchair can feel like prison.



As a friend of Elaine's, my deepest wish was that she was able to experience anything she wanted. I couldn't help her while she was alive, but, in her memory, I will do all I can to achieve accessibility for all Meadows residents in the future.

Teichroeb Brothers Story



Leland and Jason Teichroeb are brothers who are residents at "The Meadows" in Swift Current. Both are big fans of their favourite teams; the Broncos, the 57's and the Saskatchewan Roughriders. They miss not being able to attend Bronco Hockey Games and Swift Current 57's baseball games in Swift Current. Jason and Leland used to go to every home game with their Dad. Their parents have passed away, and now have been unable to attend games because of limited access for wheelchair transportation. They listen on the radio to their favourite teams, but it is not the same as being at a game. It is hard to accept that you will never be able to attend a Roughrider Football game in Regina.

Having transportation in the city to and from games in the evening would allow them the mobility to enjoy sporting events. People without physical disabilities are able to attend games and not worry about how they will get to a game. Leland and Jason are often asked why they don't attend games anymore. It is frustrating for people in Swift Current who require a total lift in a wheelchair for transportation to attend evening events.

The wheelchair Access Transit Bus in Swift Current is often all booked up during weekdays. This limits their ability to have outings during the week, as well, transportation is limited on weekends and evenings due to availability. They look forward to getting a bus for all the residents of the Meadows to have the mobility to enjoy activities that are important to them.

(DC3-C2) for Lots 1 and 2, Block B, Plan 101933759

2100 block of Saskatchewan Drive (Cypress Professional Center Ltd.)

BACKGROUND

The City has received an application to amend Zoning Bylaw 24-2014 from the property owner and developer of vacant lands located at 2101 and 2151 Saskatchewan Drive. The proposed amendments would allow apartment buildings as a permitted principal use at this particular location.

These vacant lands have a total site area of 1.9 acres and are currently zoned C3—Highway Commercial District. A Development Permit had been approved for a strip mall at this location; however, these plans are on hold pending the outcome of this request.

DISCUSSION

Under the City's Zoning Bylaw, Council has the authority to make any amendments provided they meet the intent of the City's Official Community Plan (OCP) as well as with any other development policy, bylaw or statute.

The development pattern maps of the OCP suggest a transition from a C3 District into a C2-Neighbourhood Commercial District would be suitable here, as Saskatchewan Drive moves northward from Memorial Drive before entering into the Valley Ridge residential area. The C2 District permits many of the same commercial uses allowed in the C3 District that would be compatible with or cater to the local neighbourhood, such as restaurants, professional offices, medical clinics, personal services, and retail stores.

The C2 District also permits residential dwelling units on floors above these commercial uses. However, the Applicant is requesting that stand-alone apartment buildings also be allowed as an alternative that would broaden the range of developable options for this site.

City Administration has reviewed the surrounding land uses of this area along with other areas that are currently zoned as a C2 District. It was determined that stand-alone apartment buildings as well as other neighbourhood commercial uses would be suitable development options here given its location between other commercial, institutional and high-density residential uses, but perhaps not for the other C2 Districts currently throughout the city.

The best option would be to create a direct control C2 zoning district to rezone these two lots and add apartment buildings as a permitted use. The direct control would include that any apartment buildings developed here would follow the same development standards and site regulations as the R3—High Density Multi-Unit Dwelling Residential District unless otherwise approved in a development agreement. All other land uses, standards and regulations of the C2 District will also be included in this direct control district.

To accommodate the Applicant's proposal, the following amendments to the Zoning Bylaw are required:

- 1. Amendments to Section 1.5 <u>General Definitions</u> and Part Four <u>Land Use Districts</u> by adding the text as shown in Schedule 'A'; and
- 2. Zoning Map amendments to rezone the site to DC3-C2 Direct Control Neighbourhood Commercial District for Saskatchewan Valley as shown in Schedule 'B'.

RECOMMENDATION

THAT Notice of Motion be given at this time by advising the public of Council's intent to consider amendments to Zoning Bylaw No. 24-2014 as shown in the attached Schedule 'A' and Schedule 'B'.

SCHEDULE 'A'

PROPOSED TEXTUAL AMENDMENTS TO ZONING BYLAW NO. 24 - 2014

Section 1.5 <u>General Definitions</u> is amended by *adding* the following words:

- "Apartment" means a one-unit dwelling. Typical forms may include studios, bachelor suites, and single- or multiple-bedroom suites, but do not include hotel or motel units or boarding rooms.
- "Apartment Building" means a multiple-unit dwelling divided into three or more apartments with a common entrance for the dwellings to the exterior and an internal hallway system, but does not include hotels, motels, boarding houses, townhouses, or row houses.

Part Four Land Use Districts is amended by *adding* the following section:

4.20C DC3-C2 Neighbourhood Commercial District for Saskatchewan Valley

4.20C.1 Statement of Intent

To accommodate higher-density residential dwellings and commercial uses that are generally compatible with each other and cater to the day-to-day living requirements of the local neighbourhood.

4.20C.2 Permitted Principal Uses

In the DC3-C2 District, only the following uses of land and buildings shall be permitted:

- 4.20C.2.1 all the buildings and/or uses permitted of a C2 District;
- 4.20C.2.2 apartment buildings;
- 4.20C.2.3 home-based businesses.

4.20C.3 <u>Discretionary Uses</u>

The following discretionary uses of land and buildings may be permitted:

4.20C.3.1 All the discretionary buildings and/or uses of a C2 District.


4.20C.4 <u>Development Standards</u>

4.20C.4.1 Except for apartment buildings, the prescribed development standards and site regulations of the C2 District shall apply, unless special provisions have been agreed to and specified in a development agreement.

- 4.20C.4.2 Apartment buildings shall comply with the prescribed development standards and site regulations for multiple-unit dwellings in an R3 District, unless special provisions have been agreed to and specified in a development agreement.
- 4.20C.4.3 Approval of Council shall not be required where the use and/or development conforms to the permitted principal uses of the regular districts.

In 2015 provisions were made to *The Cities Act* to improve and introduce rules surrounding, but not limited to, conflict of interest and to Council member code of ethics. This legislation was again amended in 2020 to clarify the definition of conflict of interest to better align with the common law definition.
