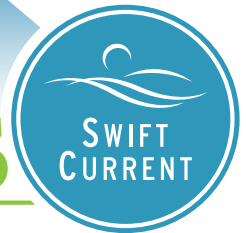


COUNCIL HIGHLIGHTS

ITEMS FOR ACTION

CORPORATE SERVICES

City Council approved General Revenue Fund disbursements in the amount of \$1,742,249.45 for the period of March 23 to April 4, 2023 and \$2,284,043.17 for the period of April 5 to 18, 2023.

PLANNING, DEVELOPMENT & ASSET MANAGEMENT

City Council gave Notice of Motion of its intention to consider amendments to Zoning Bylaw No. 24-2014. This would include rezoning an area within Saskatchewan Valley from C3 - Highway Commercial District to DC3-C2 - Direct Control Neighbourhood Commercial District and making adjustments to correct adjacent district boundaries.

CITY CLERK

City Council gave Notice of Motion of its intention to adopt a new Code of Ethics Bylaw for Members of City Council and Council Committees.

City Council amended resolution No. 83-2023 to read as: the City of Swift Current apply to the Saskatchewan Public Safety Agency to be designated an eligible assistance area under the Provincial Disaster Assistance Program (PDAP), which provides financial assistance for restoring essential residential services and property as a result of substantial damages caused by flood water that occurred during April 11th to 21st, 2023.
