CORPORATE SERVICES

City Council approved General Revenue Fund disbursements in the amount of \$1,342,944.09 for the period of January 1 to January 9, 2024.

City Council confirmed that the City of Swift Current meets the eligibility requirements to receive the Municipal Revenue Sharing Grant, authorized the City Clerk to sign the Declaration of Eligibility and submit it to the Ministry of Government Relations.

City Council approved the Fire Protection and Rescue Agreement between the City of Swift Current and the R.M. of Swift Current No. 137 and authorized the Mayor and City Clerk to sign the Agreement.

City Council approved the Mutual Aid Agreement between the City of Swift Current and surrounding communities and authorized the Mayor and City Clerk to sign the Agreement.

City Council approved the Rescue Services Agreements between the City of Swift Current and the Rural Municipalities of Whiska Creek, Coulee, Excelsior, Saskatchewan Landing and Riverside and authorized the Mayor and City Clerk to sign the Agreements.

City Council approved the Agreement between the City of Swift Current and SaskPower for the provision of rescue services at the Centennial Wind Power and the Cypress Wind Power facilities and authorized the Mayor and City Clerk to sign the Agreement.
