## **PUBLIC NOTICE MATTERS/ORDERS**

A Public Hearing was held in connection with Council's intention to consider a Bylaw to amend Zoning Bylaw No. 24 – 2014 by adding existing mobile homes as a permitted principal use in a UR – Urban Reserve District. No presentations were made.

### **ITEMS FOR ACTION**

#### CORPORATE SERVICES

City Council approved General Revenue Fund disbursements in the amount of \$1,804,830.92 for the period of February 22 to March 6, 2024.

#### **INFRASTRUCTURE & OPERATIONS**

City Council awarded the following contracts and authorized the Mayor and City Clerk to sign the said contracts:

- Active Transportation Pathway Extension Pathway Paving Contract to Southwest Paving Ltd. of Swift Current, SK, based on unit pricing to a total upset fee of \$191,253.67 (5% contingency included. PST included, and GST excluded);
- Active Transportation Pathway Extension Retaining Wall Contract to LMO Landscaping Ltd. of Swift Current, SK, based on unit pricing to a total upset fee of the approved budget of \$248,866.40 (10% contingency included. PST included, and GST excluded);
- 2024 Paving and Concrete Contract to United Paving Ltd. of Swift Current, SK, based on unit pricing to a total upset fee of the approved budget of \$1,457,089.79 (5% contingency included, PST included, and GST excluded);

- 2024 Pavement Maintenance Contract to United Paving Ltd. of Swift Current, SK based on unit prices to a total upset fee of \$415,000 (including PST, excluding GST); and
- 2024 Microsurfacing Program Contract to West-Can Seal Coating Inc. of Didsbury, AB based on unit prices to a total upset fee of \$265,919.55 (including PST, excluding GST).

City Council awarded the following contracts and authorized the Mayor and City Clerk to sign the said contracts:

- Larue D40 snow blower from Falcon Equipment of Regina, SK in the amount of \$193,953.50 (PST included, GST excluded);
- Case 721G Loader from Redhead Equipment Ltd. of Swift Current, SK in the amount of \$264,846 (PST included, GST excluded); and
- Six (6) light duty trucks from Cypress Motors Ltd. of Swift Current, SK in the amount of \$468,150.28 (PST included, GST excluded).

## **COMMUNITY SERVICES**

City Council approved the recommended funding amounts under the 2024 – 2025 Saskatchewan Lotteries Community Grant Program.

## **BYLAWS**

City Council passed a Bylaw to amend Cemetery Bylaw No. 3 – 2017 to accommodate textual amendments and incorporate rates and fees as a schedule.
