ITEMS FOR ACTION

CORPORATE SERVICES

City Council approved General Revenue Fund disbursements in the amount of \$1,748,239.27 for the period of May 31 to June 11, 2024.

City Council awarded a contract for managed payroll services to Dayforce to an upset value of \$125,424.29 (PST included, GST excluded); approved the one-time setup fee for managed payroll services of \$40,545.00 (PST included, GST excluded); and authorized the Mayor and City Clerk to sign the contract.

COMMUNITY SERVICES

City Council awarded the tender for the supply and replacement of the RC Dahl Centre Roof to Optimum Roofing Ltd. of Regina, SK for the sum of \$811,209.52 PST included, and GST excluded.
