PROCLAMATIONS

DELEGATIONS

PUBLIC HEARING

A Public Hearing was held in connection with Council's intention to consider an application with respect to an existing discretionary use, being a Daycare Centre located at 610 – 19th Avenue NE.

Nine letters opposing and one letter supporting the application were received before the deadline. Two presentations were made, one in opposition and one in support.

ITEMS FOR ACTION

CORPORATE SERVICES

City Council approved the General Revenue Fund disbursements in the amount of \$1,831,597.17 for the period of August 21 to September 4, 2024.

City Council accepted the 2024 List of Lands with Arrears as presented.

City Council gave notice of motion of its intention to amend Capital Reserve Bylaw No. 8 – 2014.

LIGHT & POWER

City Council approved the Powerline Pole and Transformer changes as a project for the 2024 fiscal year, the reallocation of funds in the sum of \$146,000 from the System Improvement to the Powerline Pole and Transformer Change Project and awarded the project to Neuls Holdings Inc. of Craven, SK, in the amount of \$132,500 (PST included, GST excluded).

COMMUNITY SERVICES

City Council supported the development of a phased approach to the completion of an Aquatics Leisure Facility and that Administration be directed to apply for grant funding through the Green and Inclusive Community Buildings Grant – Round 3. City Council agreed to meet the terms and conditions of the relevant program, to conduct an open tendering process, to manage the construction of the project and to follow any Federal and Provincial Environmental Legislation and Standards. City Council deemed this project to include the completion of an Aquatic Centre and atrium area and to fund the municipal share by debt with the ongoing operations and maintenance costs funded by way of municipal taxes.

PLANNING & DEVELOPMENT

City Council approved the consolidation of Lots 2 & 3, Block 2, Plan 80SC11266 Ext's 0 and that the Mayor and City Clerk be authorized to sign the Certificate of Approval.

NEW BUSINESS

City Council received and filed the following:
